Terms and Conditions

Prize Draw

1. This prize draw (“the Prize Draw”) is a chance to win one of three Thomas Cook holiday vouchers available, each to the value of £3,000 (“the Vouchers”).
2. The Prize Draw begins on 1st October 2018 and closes on 31st December 2018 (the “Closing Date”) (this period being the “Qualifying Period”).
3. To qualify to enter the Prize Draw a minimum of a £150 worth of JCB branded lubricants (“Lubricants”) is required to be purchased during the Qualifying Period from a participating authorised JCB construction dealer in the UK (not including Northern Ireland/Eire) in one single transaction. The Lubricants can be purchased as part of an over the counter transaction only or Lubricants purchased as part of a machine service transaction, provided that the threshold value is met in one single transaction.
4. Owner-operators or organisations will receive one entry for spending between £150 and £249, two entries for spending between £250 and £349 and three entries for spending £350 or more during the Qualifying Period to a maximum of 20 entries per owner-operator or organisation.
5. In order to submit your entry you need to log your invoice for the relevant Lubricants transaction(s) as proof of your purchase on the Prize Draw website www.goplaces.jcb.com. The closing date for logging any eligible invoices dated from within the Qualifying Period is Friday 18th January 2019.
6. Each entry will be placed into a regional draw (Northern territory, Central region and Southern territory each as determined by JCB), with the regional draw in which your entry will be placed to be determined by reference to the JCB construction dealer from whom you purchased the Lubricants.
7. One winner will be drawn at random from each of the three regional draws. The winners will be drawn on 30th January 2019 and the Winners will be announced on 31st January 2019.
8. The winners will be notified by email (in the case of an organization winner this shall be both to the nominated contact and a director). Those individuals undertaking the procurement on behalf of an organization note that it is the organization that shall receive the entries. Accordingly, if the winner is an organization it is for that business to determine the individuals who are to receive the Vouchers.
9. JCB reserves the right to re-draw the prize for each regional draw if the winner for that region cannot be contacted within a reasonable period of time (which shall be in JCB’s sole discretion).

The Vouchers

10. Prizes are awarded ‘as is’ with no warranty or guarantee, either express or implied.
11. The Vouchers are subject to Thomas Cook’s terms and conditions.
12. There is no cash alternative to the Vouchers and they are non-transferable and non-refundable in whole or in part.
13. The Vouchers must be redeemed within two (2) years of the date printed on the Vouchers.
14. The winner and travelling companions are solely responsible for their own travel arrangements including but not limited to any passports, visas, insurance, spending money and any other additional travel costs or expenses.
